Statement of Purpose

- (e) to assist other educational and charitable organizations in the conduct of similar activities; and
- (f) to engage in any and all lawful activities incidental to the foregoing purposes except as restricted herein.

Program Highlights

The Foundation continued all existing programs while adding new ones during the 2010-2011 operating year.

The Foundation has enjoyed a successful, albeit fiscally challenging year. Highlights of the Foundation's activities most recent activities include the creation of *Club 159* (the initiative was conceived to supplement the COF Capital Campaign Fund 2011), award of a Department of Defense grant to conduct an assessment of the Health Initiative for African Safety and Stability (HIFASS) in Abuja, Nigeria, and the Scientific and Training Symposium, held in New Orleans during June.

The Anchor and Caduceus Dinner, held the opening night of the Symposium, celebrated the 122nd anniversary of the establishment of the PHS Commissioned Corps as a uniformed service in 1889 and the 213th anniversary of the forerunner of the U.S. Public Health Service, the Marine Hospital Service. The Dr. C. Everett Koop Honorary Lecture was delivered by Rear Admiral Nicole Lurie, USPHS, Assistant Secretary for Preparedness and Response, U.S. Department of Health and Human Services.

The Foundation continued the partnership of the Rear Admiral Jerrold M. Michael Fellowship and the University of Maryland School of Public Health. The second group of PHS Commissioned Corps fellows will shortly complete the Global Health Certification program as RADM Michael Fellows. The graduate credits earned will be fully applicable to further study leading to an advanced degree in the field of public health. The third group of fellows has already enrolled in 2011-2012 academic year program.

In an effort to put the lessons learned at the foundation's two Global Health Summits to work, the Foundation is now actively engaged in improving health literacy and education.

The Foundation received a Department of Defense grant to assess all aspects (organization, financial, planning, human resources, advocacy, etc.) of the Health Initiatives for African Safety and Stability (HIFASS) in Nigeria. The foundation deployed a two-person team to Nigeria to conduct the assessment under the auspices of the Military HIV Research Program (MHRP). Following the on-site evaluation, the foundation team produced a comprehensive 173 page report. The grant project was successfully completed on time and within budget.

The Foundation's publishing arm produced its fourth book, *Public Health Emergency Preparedness & Response: Principles & Practice*, which meets a critical need of public health emergency responders for a ready source of information that is applicable both as a desktop reference and field manual. This book is edited by Richard H. Carmona, MD, MPH, 17th Surgeon General of the United States; CAPT Robert G. Darling, MC, USN (Ret.); CAPT James E. Knoben, USPHS (Ret.); and RADM Jerrold M. Michael, USPHS (Ret.).

As the Foundation grows and becomes more widely known, a direct result is greater awareness, understanding, and support for the PHS Commissioned Corps and its role in protecting and advancing not only the Nation's public health, but also the health of the global community.

ANNUAL USPHS SCIENTIFIC AND TRAINING SYMPOSIUM

Attendees at the 46th annual PHS Scientific and Training Symposium held in New Orleans, LA in late June were treated to an outstanding scientific program, well-received keynote speeches by the Health Commissioner of the City of New Orleans and the Assistant Secretary for Preparedness and Response, and a taste of Mardi Gras and “second line” dancing New Orleans style! The symposium was once again an international event with representatives in attendance from the People’s Republic of China and Nigeria.

Unfortunately, due to severe restrictions on HHS support for officers to attend the symposium fewer than 750 officers were able to participate. That marks the second smallest turnout for a PHS Symposium in the last ten years. From all reports, though, those they were able to attend found the symposium highly worthwhile.

The symposium’s opening plenary session featured the Assistant Secretary for Health, The Honorable Howard Koh, MD, MPH, speaking on the future of the PHS Commissioned Corps emerging from the management and mission review completed in 2010.

After Dr. Koh’s remarks, Captain Michael Noska, USPHS – Senior Advisor for Health Physics, Office of the Commissioner, U.S. Food and Drug Administration spoke of the Public Health Response to the Japanese Nuclear Power Plant Crisis at Fukushima.

The Luther Terry Lecture was delivered by Dr. Karen DeSalvo, Commissioner of Health, City of New Orleans. Dr. DeSalvo addressed how the City of New Orleans has managed the public health and medical needs of the community in the six years following the Hurricane Katrina Disaster.

The Deepwater Horizon Disaster was the subject of a panel discussion moderated by RADM Scott Deitchman, USPHS – Associate Director for Emergency Response, National Center for Environmental Health and Agency for Toxic Substances and Disease Registry, Centers for Disease Control and Prevention. The panelists included RADM James Galloway, USPHS, Regional Health Administrator for Region V; RADM Roy Nash, U.S. Coast Guard; Captain James Spahr, USPHS; and Pertti (Bert) Hakkinen, PhD – senior toxicologist, National Library of Medicine. This expert panel described the federal government’s public health leadership during the Deepwater Horizon emergency response. The session closed with an opportunity for dialogue and a question/answer period with panel members.

Over 40 pints of blood were collect during the 2011 Unformed Services Blood Drive conducted during the opening day afternoon.

The day concluded with the Ensemble concert and Anchor and Caduceus Dinner in the evening. The Anchor and Caduceus Dinner celebrates the founding of the Public Health Service as well as the birthday of the PHS Commissioned Corps. Rear Admiral Nicole Lurie, USPHS – Assistant Secretary for Preparedness and Response, U.S. Department of Health and Human Services delivered the C. Everett Koop Honorary Lecture at the dinner.

Run/Walk:

In conjunction with the training symposium, COF sponsored the Surgeon General's 5k Run/Walk. The Run/Walk activity helped to evidence the importance of health in the 21st century. The Deputy Surgeon General, RADM Boris Lushniak, USPHS started and participated in the event involving over 400 health professionals, partners and friends of public health.

Awards:

Among the many highlights were awards to recognize technical expertise in public health and awards in other related disciplines. For example, the Health Leader of the Year Award—which was established in 1987 to recognize individuals who have made notable contributions to the health of the nation was given to Senator Jeff Bingaman for his leadership as a champion of the public health legislation in Congress. The 2011 John C. Villforth Leadership Award recognizing the exemplary work of senior career leaders in the USPHS was presented to Captain Anthony T. Zimmer, , USPHS with the Environmental Protection Agency, and a director of the Commissioned Officers Association of the USPHS.

The successes of the training symposium were primarily due to the planning committee—which was made up of talented and dedicated volunteers. The committee, co-chaired by RADM Boris Lushniak and RADM Kevin Meeks, was also responsible for the overall planning and coordination of the training symposium.

NOTE A - ORGANIZATION AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Organization The PHS Commissioned Officers Foundation for the Advancement of Public Health, Inc. (the Foundation) was established June 7, 2000 as a separate organization authorized by the Board of Directors of the Commissioned Officers Association of the United States Public Health Service, Inc. (COA).

The Foundation receives, administers and expends funds for education and training for health professionals and conducts studies and research.

The Foundation is supported primarily by contributions and income from the annual meeting and events.

Basis of Accounting The accompanying financial statements are presented on the accrual basis of accounting. Consequently, revenue is recognized when earned and expenses when incurred.

Income Taxes The Foundation is exempt from Federal income taxes under Section 501(c)(3) of the Internal Revenue Code (the Code) and has been determined by the Internal Revenue Service not to be a private foundation within the meaning of Section 509(a) of the Code.

The Foundation requires that a tax position be recognized or derecognized based on a "more-likely-than-not" threshold. This applies to positions taken or expected to be taken in a tax return. The Foundation does not believe its financial statements include, or reflect, any uncertain tax positions. The Foundation's IRS Form 990, Return of Organization Exempt from Income Tax returns for 2010, 2009 and 2008 are subject to examination by the Internal Revenue Service, generally for three years after they were filed.

Fixed Assets The Foundation capitalizes all fixed asset acquisitions of \$500 and above. Fixed assets are recorded at cost, if purchased, or fair market value at date of donation, if contributed. Depreciation is provided on a straight-line basis over the estimated useful life of the asset.

Cash and Cash Equivalents The Foundation considers all cash accounts with a maturity of three months or less to be cash equivalents.

Accounts and Contributions Receivable Accounts and contributions receivable are stated at the amount management expects to collect. No allowance for doubtful accounts has been established since management considers all amounts to be fully collectible.

Deferred Revenue	Deferred revenue consists of an amount that was collected by the Foundation prior to year-end for which the services will be performed subsequent to year-end.
Reclassification	Certain 2010 amounts have been reclassified for comparative purposes.
Estimates	The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.
Contributions	The Foundation reports gifts of cash and other assets as temporarily restricted support if they are received with donor stipulations that limit the use of the donated assets. When a donor restriction expires, that is, when a stipulated time restriction ends or purpose restriction is accomplished, temporarily restricted net assets are reclassified to unrestricted net assets and reported in the statement of activities as net assets released from restrictions.
Prior Year Information	The financial statements include certain prior year summarized information in total but not by net asset class. Such information does not include sufficient detail to constitute a presentation in conformity with accounting principles generally accepted in the United States of America. Accordingly, such information should be read in conjunction with the Foundation's financial statements for the year ended June 30, 2010, from which the summarized information was derived.

NOTE B - CONCENTRATIONS

The Foundation maintains cash balances at financial institutions in the Washington, DC metropolitan area. The accounts at these institutions are insured by the Federal Deposit Insurance Corporation (FDIC) up to certain limits. At times during the year, the Foundation's cash balances exceeded the FDIC insurance amount. Management believes the risk in these situations to be minimal.

NOTE C - RELATED PARTY TRANSACTIONS

The Foundation shares office space and other related expenses and services with the COA. In addition, the Foundation participates in a joint annual meeting with COA. Expenses incurred by the Foundation and COA are allocated on a reasonable basis as mutually agreed upon in a consistent manner. As of June 30, 2011, COA owes the Foundation approximately \$103,000.

NOTE D - FUNCTIONAL EXPENSES

The costs of providing the various program and other activities have been summarized on a functional basis in the statement of functional expenses. Accordingly, certain costs have been allocated among the programs and supporting services benefited.
