Historically, Corps careers were in a "tenure" system, where most officers could reasonably expect to attain O-5 and then O-6 rank if they stayed in long enough. The Corps thus developed a culture consistent with a tenure-based system. We each were raised in that culture. It affected how we think of our own careers, how we evaluate ourselves for our career progress, how we relate to one another as professionals. Over the last several years, changes in promotion rates have implicitly structurally transformed the Corps from a tenure-based system to a pyramidal system. The more disconnect between a tenure-based, guild-style culture (the USPHS many of us joined) and our current organizational structural reality, the more distress we will experience. The more difficult it will be to feel we are "succeeding" or that our careers are meaningful, that our professional lives are "on track." We are literally, many of us, asking ourselves why we are losing at a game, when in fact what has happened is the rules have changed and we are playing by old rules. This presentation suggests some ways to rethink our professional lives, and our professional culture, so that we are playing by new rules for career success based on other criteria than rank promotion, and suggests cultural changes individual officers and HS PAC as a group could make.
